- Minimum of 20 persons required to prebook. Rate may vary based on selected date and number of persons.
- Use of TangleWoods Cash Bar
- Rate includes entrance between 9am and 6pm and (5 hours) venue hire with tables, chairs and self braai facilities.
- Self-catering clients make own arrangements, inclusive cutlery, crockery, serving dishes, tongs, wood etc.
- Note: Clients will not have access to TangleWoods kitchen for self-catering arrangements.

OPTIONAL - SERVICE FEE R30 P/P

Includes

- Dinner and side plate, dessert bowl, knife, fork and dessert spoon,
- Buffet table with table linen.
- Serving dishes, serving spoons, and braai tongs
- R500 breakage deposit required, refunded within 7 days of function date.

OPTIONAL - SALAD & STARCH R20

We provided Braai sides. Minimum of 20 persons. Price is per person and per selected item.

- **Starch:** Garlic Bread, Pap and Sauce, Garlic Potatoes, Sweet Potato Bake, Creamy Potato Bake, Honey Pumpkin, Braai Broodjies.
- **Salad:** Coleslaw, Beetroot and Feta Salad, Greek Salad, Potato Salad, Bread Salad, Carrot Salad

OPTIONAL - BEVERAGE STATION

Self Serving Beverage Station:

- **Hot Beverage Station:** R35 p/p. We provide an Urn, instant coffee, tea, sugar, milk, cups and saucers. (2 cups per person)
- **Cold Beverage Station:** Lemon & Mint Water, and Fruit Juice R35 p/p. Served in large beverage dispenser with glasses. (one glass per person)
- **Alcoholic Beverage Station:** Watermelon & Mint Vodka Fizz or Moscow Mule R45 p/p. Select 1. Served in a Beverage dispenser or drinking jar with straws (one glass per person)

VENUE TERMS

These terms are applicable to self-catering venue hire.

Liquor License: TangleWood is fully licensed. No own beverages and or alcohol allowed. Corkage fee of R35 per 750ml bottle of wine or sparkling wine will apply by prior arrangement only.

Appointments and Arrangements: Please make an appointment with the office for viewing and final arrangements, All arrangements must be in writing. Final arrangements must be confirmed 10 days before the event with office@tanglewoodnatureestate.com

Deposit & Confirmation: Quotes are valid for (7) days only and a 50% deposit is required to confirm your booking. Full outstanding balance must be received latest 7 days before date of event. No function will take place unless the full account has been settled. Tanglewood reserves the right to cancel if full payment is not received before the function date.

Rescheduling and Cancellations: Cancellation terms apply to a postponement and/or date change. In general, deposits are non refundable unless TangleWood rebooks your function date with a new client. Costs incurred by TangleWood will be deducted from any refund amount.

Weather: TangleWood does not accept responsibility for delays, postponements, or cancellations as a result of weather and its associated effects.

Music and Noise: TangleWood runs a low noise campsite/property. Client may not play music including via radio, cell phone or any other musical instrument. TangleWood may play soft background music from the bar, however volume is controlled to ensure no impact on other clients.

Damages/Breakages: Client is responsible for guest damages and breakages at replacement cost.
